## City Hall begins limited reopening Tuesday as part of Phase 1.5

All other facilities remain closed under City plan that follows Ad Astra phases

ARKANSAS CITY, Kan. (May 16, 2020) — The City of Arkansas City will begin a very limited reopening of City Hall on Tuesday as part of Phase 1.5 of Kansas Gov. Laura Kelly's Ad Astra state reopening plan.

To maintain the health of its employees and help to limit the spread of coronavirus (COVID-19) locally, the City closed City Hall to the public in late March. However, City staff has continued to provide public services during this time through a variety of measures, including by telephone, video conferences, in-person appointments, and online, drive-through and drop-off methods.

Starting Tuesday, Arkansas City Municipal Court will resume weekly sessions with strict social distancing and other safeguards in place to protect everyone's health. (See attached plan for more.)

Police officers will monitor the main doors to City Hall and only seven people will be allowed in the building at a single time in order to maintain the limit of 10 people established in Executive Order 20-31.

The Finance Department also plans to bring back the walkup window next week for cash payments.

Through Phase 1.5 and Phase 2, all other public business at City Hall will continue to be conducted online, by telephone or email, or via appointments. City Hall will be unlocked only during court hours.

Critical services such as Fire-EMS, police, sanitation, water, wastewater and others will continue uninterrupted. All other City facilities, including the following, will remain closed to the public in Phase 1.5:

- Agri-Business Building, located at 712 W. Washington Ave.;
- Arkansas City Public Library, located at 120 E. Fifth Ave.;
- Cleo Graves Memorial Hogan, located in Ranney Park at 326 E. Poplar Ave.;
- Northwest Community Center, located at 615 W. Birch Ave.;
- Senior Citizens Center, located at 320 South A St. (but meal program is continuing);
- Recycling trailers located at the middle school, Cowley College and Spring Hill Golf Course.

The City continues to encourage all citizens to follow all health recommendations when using City parks or trails, including safe social distancing methods, and to refrain from using these areas while sick.

- Use the utility dropbox located in the alley east of City Hall to drop off your payment.
- Use the City of Arkansas City dropbox located at the Dillons customer service counter.

For those residents who wish to pay with cash, the following service is available:

Use the walk-up window, located just to the right (east) of the main (south) door to City Hall.

To establish or stop utility service, please call <u>441-4401</u> or <u>441-4402</u> to talk to a customer service specialist, or use the walk-up window. The walk-up window also is available for court payment plans.

#### Neighborhood Services Division: Building permits, code enforcement, planning and zoning

### **Other City facilities**

Including City Hall, all City facilities housing City personnel remain off-limits to the public indefinitely, except for exceptional circumstances. This restriction includes the Bryant Shop, Central Shop, Fire-EMS Department, Parks Shop, Police Department, Water Treatment Facility and Wastewater Treatment Plant.

The Meals on Wheels program will continue indefinitely as a curbside pickup or delivery service only.
